## **DME Providers**

### **New NDC Requirements**

This is a reiteration of DME Bulletin 7107c, published October 2007.

To comply with Centers for Medicare & Medicaid Services (CMS) requirements related to the Deficit Reduction Act, a number of changes involving drug-related HCPCS will become effective with dates of service on and after January 1, 2008. Providers have already been required to submit at least one valid National Drug Code (NDC) for all drug-related HCPCS on noncrossover claims starting January 1, 2007. However, effective with dates of service on and after January 1, 2008, Medicare crossover claims for beneficiaries with both Medicare and Medicaid will no longer be excluded. In addition, drug-related HCPCS codes with submitted NDCs not eligible for drug rebate will be denied.

*Note:* The Kansas Medical Assistance Program (KMAP) is developing a feature on the KMAP Web site that will provide specific rebate information on NDCs. This feature will be available January 1, 2008.

The following future requirements and restrictions apply when billing for prescription drug products in an office or outpatient setting using a drug-related HCPCS, effective with dates of service on and after January 1, 2008:

- Medicare crossover claims for beneficiaries with both Medicare and Medicaid will
  require at least one NDC to be submitted for drug-related HCPCS codes. If at least
  one valid NDC is not submitted, the HCPCS detail will be denied. If the HCPCS
  detail is comprised of more than one NDC, each applicable NDC is to be submitted,
  up to 25 NDCs. See additional information below regarding current NDC
  requirements.
- 2. If an NDC is submitted with a CMS Termination Date in effect for the service dates, the HCPCS detail will be denied. A CMS Termination Date indicates the product has been discontinued. This occurs if the product is being replaced, discontinued (the shelf life expiration of the last batch sold), or pulled from the market because of health or safety reasons.
- 3. If an NDC is submitted with a Drug Efficacy Study Implementation (DESI) value indicating it is less than effective for all indications or is less than effective and has been withdrawn from the market, the HCPCS detail will be denied.

- 4. If an NDC is submitted whose manufacturer or labeler does not have a rebate agreement with CMS in effect for the service dates, or the NDC is not rebate-eligible, the HCPCS detail will be denied.
  - To avoid claim denials, providers are advised to evaluate their drug supplies to ensure that drug products administered starting January 1, 2008, are purchased from participating manufacturers. To view a list of participating labelers, visit the following Web site:

- 5. If an NDC is submitted that does not match the HCPCS being billed, the HCPCS detail will be denied. For example, HCPCS J2175 (injection, meperidine hydrochloride, per 100 mg) is billed, but an NDC for morphine is submitted.
- 6. If a nonspecific drug-related HCPCS code (such as J3490) is billed, a valid NDC quantity is required to be submitted or the claim detail will be denied. See the section titled "Drug-Related Nonspecific HCPCS Codes" at the end of this bulletin for a complete list of nonspecific HCPCS codes that will require a valid NDC quantity.

*Note:* Public Health Service providers who have not carved out Medicaid and are submitting 340B prices to Medicaid are not required to submit NDC information.

#### **Current NDC Requirements**

- 1) If one NDC makes up the HCPCS code being billed, provide the following information:
  - a) Submit a valid NDC that reflects the content of the HCPCS code being billed.
     The NDC must be an 11-digit code unique to the manufacturer in a 5-4-2 format (99999-9999-99). The 837 transaction data element is LIN03 Product/Service ID.

*Note:* If only one NDC makes up the HCPCS being billed, the NDC Quantity, NDC Unit of Measurement Code, and NDC Unit Price fields are not required. For 837 transactions, if a value is submitted for one of these three fields, data must be submitted for all fields. Therefore, KMAP recommends only submitting the NDC. However, if you choose to submit these fields, the fields must be in valid formats. If the actual values are not known, select or enter the following default values:

- NDC Quantity: **0.000**
- NDC Unit of Measurement: **F2** (international unit)
- NDC Unit Price: \$0.00

*Exception:* Beginning with dates of service on and after January 1, 2008, a valid NDC quantity will be required on all NDCs submitted for one of the drug-related nonspecific HCPCS codes. See the section titled "Drug-Related Nonspecific HCPCS Codes" at the end of this bulletin for a complete list of nonspecific HCPCS codes that will require a valid NDC quantity.

2) If more than one NDC makes up the HCPCS code being billed, provide the following information:

- a) Submit a valid NDC for *each* NDC used to make up the HCPCS code, up to 25 NDCs. Each NDC must be an 11-digit code unique to the manufacturer in a 5-4-2 format (99999-9999-99). The 837 transaction data element is LIN03 Product/Service ID.
- b) Submit a valid NDC Quantity for *each* NDC used to make up the HCPCS code. The NDC Quantity must be a numeric value greater than zero. Up to three digits to the right of the decimal point are available. The NDC Quantity is to reflect the number of NDC billing units administered, and in most cases will be different than the number of HCPCS units billed. The 837 transaction data element is CTP04 Quantity.

*Note:* Users of the batch 837 health care claim and encounter transactions (professional and institutional) should be aware the NDC Quantity, NDC Unit of Measurement (UOM) Code, and NDC Unit Price make up a single data segment or 'loop.' If a value is submitted for one of these fields, data must be submitted for all three. If the NDC Quantity is required due to more than one NDC making up the HCPCS code being billed, default values can be submitted for the NDC UOM and Unit Price if not known. The following values can be set up as defaults within individual billing software programs or can be entered manually:

- NDC UOM default value: F2 (international unit)
   Other valid values are GR (gram), ML (milliliter), and UN (unit)
- NDC Unit Price default value: **\$0.00**

*Exception:* Beginning with dates of service on and after January 1, 2008, a valid NDC quantity will be required on all NDCs submitted for one of the drug-related nonspecific HCPCS codes. See the section titled "Drug-Related Nonspecific HCPCS Codes" at the end of this bulletin for a complete list of nonspecific HCPCS codes that will require a valid NDC quantity.

For **paper claim** users, a KMAP form entitled NDC Detail Attachment is to be filled out and attached to the paper claim when billing for drug-related HCPCS codes. The NDC Detail Attachment form is included in this bulletin and can be used to make photocopies.

These NDC specifications are applicable to all electronic, Internet, and paper claim submissions. The NDC, NDC Quantity, NDC UOM, and NDC Unit Price fields are available for users of the batch 837 health care claim and encounter transactions (professional and institutional).

Effective with dates of service on and after January 1, 2008, the following HCPCS codes will require a valid NDC quantity to be submitted for each NDC billed:
